RIDE-ALONG WAIVER

ATTENTION!! READ THIS DOCUMENT IN FULL BEFORE SIGNING!!

Whereas, I, _____ (name), being/not being over the age of eighteen and not being a member of the Moberidge Police Department, have made a voluntary request to ride as a guest in a police vehicle assigned by the City of Moberidge to the Moberidge Police Department and to accompany a member or members of the Moberidge Police Department during the performance of their duties. I agree:

1. That I am aware that the work of the Moberidge Police Department is inherently dangerous and that I may be subjected to the risk of death or personal injury or damage to my property by accompanying a member or members of the Moberidge Police Department and that I freely, voluntarily, and with such knowledge assume the risk of death, personal injury, or property damage arising from or in arising from or in any way connected with the use of weapons: unlawful acts or forcible resistance by law violators or suspected law violators, assault, riots breach of the peace fire, explosion, gas, electrocution, or the escape of radioactive substance while accompanying a member or members of the Moberidge Police Department.

2. That the City of Moberidge, the Moberidge City Council, Moberidge City Finance Officer, its officers and the employees of the City of Moberidge, Moberidge Chief of Police, all officers and members of the Moberidge Police Department, and each of them, shall not be responsible or liable for any injury, damage, loss or expense, either to me or my property, incurred while riding in any vehicle assigned to the Moberidge Police Department or while accompanying any member or members of said department and resulting from any negligent act or omission on the part of any member of the Moberidge Police Department whether written or outside their scope of employment.

3. For myself, my heirs, executors, administrators, and assigns to defend and indemnity the City of Moberidge, the Moberidge City Council, Moberidge City Finance Officer, its officers and the employees of the City of Moberidge, Moberidge Chief of Police, all officers and members of the Moberidge Police Department, and each of them, against any and all manner of actions, causes or actions, suits, debts, claims, demands, or damages or liability or expense of every kind and nature incurred or arising by reason of actual or claimed negligent or wrongful act or omission of mine while riding in any vehicle assigned to the Moberidge Police Department or while accompanying any member or members of the Moberidge Police Department.
